



# EMERGE Gender Questions Partner Violence, Sexual Exploitation and Cyber-Abuse

#### **IMPORTANT CONSIDERATIONS:**

- Protections should be in place to support those who are victims of violence, and to ensure we do not increase their risk by asking them to disclose this information in a phone interview. Please see the following WHO recommendations for conducting ethical research on domestic violence:

- We would highly recommend you have a hotline number or other way of providing referrals to health resources for all participants assessed via these items. You may wish to assess which items to include in your survey based on the referrals you will be able to provide to respondents.

### **Conflict and Violence in Relationships**

Now I would like to ask you about your difficulties that may be occurring in your relationship. It is normal in many relationships for fighting to occur, but sometime it can result in one partner hurting the other. I would like to ask you some questions about whether this has happened to you in your current relationship, in the past 12 months. Your responses can be:

- a. Yes, in the past 12 months
- b. Yes, but not in the past 12 months
- c. No, never
