- 3. As a result of any of these concerns, did you (personally) experience any of the following consequences in the past 5 years? (For those who responded 2-5 in Question 1)
 - a. Injury
 - b. Illness

 - d. Injury/illness of a household member
 - e. Family violence occurred (for example, abuse of wife or children)
 - f. Household member is missing
 - g. Dwelling is damaged
 - h. Dwelling is destroyed
 - i. Personal income decreased (question refers to individual, not overall household income)
 - Crops that I grow were damaged or destroyed
 - k. Livestock that I raised was lost or contracted serious illness
 - I. Productive assets I personally own or use (land, industrial assets, machinery, productive services, etc.) were damaged or destroyed

- m. Children's school was cancelled or reduced
- n. Migrated to different geographical area
- o. Obtained or applied for refugee status
- p. Experienced another form of forced displacement (including pre-emptive evacuation)
- q. Drinking water source was damaged/compromised
- r. Water shortages affected my household's water use
- s. Time spent on water collection increased
- t. Time spent of child care increased (including physical care, teaching, playing)
- u. Time spent caring for adult family members increased (including administrative support, physical care, psychological support)
- v. Time spent on any domestic work activities increased (services provided for the household, including cleaning, cooking, shopping for the household, repairs, décor, pet care, livestock care)
- w. Had to switch to unclean cooking/heating/lighting fuel for more than two weeks (e.g. any fuel apart from electricity, LPG, natural gas and biogas)
- x. Time spent on fuel and firewood collection increased
- y. Lost job
- z. Had to switch to unimproved form of sanitation (Pit latrine without slab, bucket, hanging toilet or bushfield)
- aa. Had to start sharing sanitation facilities with other households
- bb. Found difficulties accessing hygiene products
- cc. Experienced longer wait times to visit doctor to seek medical care
- dd. Was unable to seek necessary medical care
- ee. Was unable to seek necessary medical care for family
- ff. Mental health was affected (experienced stress, anxiety)
- gg. Crime increased in the area where I live or work
- hh. Someone I know has been a victim of violence
- ii. I got my son/daughter married earlier than I would have liked to
- ij. Someone I know married off their son/daughter earlier than expected
- kk. Own vehicle was damaged
- II. Lost access to/could not use public transportation
